With a view to taking up women issues and problems. It provides a platform for women to share their Experiences and views regarding Society and to Suggest ways to improve them. Aiming at intellectual and social upliftment of the female students and staff.

### **Vision**

We envision a self esteem dignity and protection of female fraternity at SIRRCOE. We strive for redress of complaints of any harassment and to ensure gender equality in the campus.

### **Mission**

1. To provide safe workplace.
2. To ensure the implementation of the policy in letter and spirit through proper reporting of the complaints and their follow-up procedures.
4. To uphold the commitment of the Institute to provide an environment free of gender based discrimination.
5. To promote a social and psychological environment to raise awareness on sexual harassment in its various forms.

### **2.1. Functions& Responsibilities:**

- a. The Cell will provide assistance to the Faculty / Institute for taking preventive steps in the matter of gender discrimination and sexual harassment
- b. The Cell shall process all the individual complaints and take suitable action thereon in the manner and mode as per the college norms.
- c. The Cell will deal with the cases / complaints of sexual harassment and any other type of harassment of the female students, teaching and non-teaching women staff of the college.
- d. The Cell may form / review the guidelines / policy for the grievance redressal as required from time to time, which may be in accordance with those issued by Supreme Court and Government Agencies.

### **2.2. Grievance Procedure**

- a. Any women employee or female student will have the right to lodge a complaint concerning sexual harassment against a male student or the employee of the institute by writing a letter or putting the complaint in the Principal's office or she can lodge her complaint through online anonymous grievance form available on college website without revealing identity too.
- b. The complaint will be afforded full confidentiality at this stage.
- c. After receiving the complaint, the chairman shall convene the meeting of the cell.

- d. The chairman will appoint investigation committee, Coordinator will convene the meetings.
- e. The investigation committee shall then decide the course of action to proceed.
- f. The complaint will stand dropped if in accordance to the committee the complaint has not been able to disclose prima-facie an offence of sexual harassment by complainer /her representative.
- g. In case the investigation committee decides to proceed with the complaint, the wishes of the complainer shall be ascertained and if the complainer wishes that a warning will suffice then alleged offender shall be called to the meeting of the committee, heard and if satisfied that a warning is just and proper, he will be warned about his behaviour and non-occurrence of it. In case the complainer requests that the complaint should be proceeded with beyond mere a warning, the same may be proceeded with in the manner prescribed hereafter.

### **2.3. Punishment Procedure**

Any member of the institute fraternity (student/employee/outsider related to institute) found guilty of sexual harassment shall be liable to be punished. This shall be subject to the same penalties for major or minor misconduct as prescribed under government/ university rules.

A student guilty of sexual harassment shall be liable for any of the following penalties:

1. Warning or reprimand.
2. Suspension/ Rustication from the college as the case may be
3. Any other punishment as defined by the government/ university

### **2.4. Protection against Victimization**

The committee noted and approved the policy on Protection against Victimization as following-

- (a) In the event of the complainer being a student and the accused being a teacher, during the pendency of the investigation and inquiry and even after such an enquiry if the teacher is found to be guilty, the accused will not act as an examiner for any examination for which the student appear.
- (b) In the event the complainer and the accused both being employees, during the pendency of the investigation and enquiry even after such an enquiry if the accused is found to be guilty, the accused shall not write the condition reports of the complainer, if it is otherwise so authorized.

### 3. GENDER AUDIT

#### 3.1 Introduction

Gender audit is a tool to assess and check the institutionalization of gender equality into companies, consisting of regulations, programs, projects provision of services, structures, proceedings. It increases the collective capacity of the group to examine the sports from a gender angle and to discover strengths and weaknesses in promoting gender equality issues. Gender audit is an critical parameter for any enterprise.

There shall not be any kind of discrimination on the basis of Gender

- The institution shall provide equal opportunity for all genders
- Freedom for all genders to express of free and fair opinion
- There must be an accessible, active, unbiased and confidential grievance redressal cell
- The institute shall arrange effective measures for the safety and security of all gender

#### 3.2 Objectives

The Gender Audit has the following objectives:

- To find out the areas where gender imbalance exists and the factors behind it
- To establish good gender balance in decision-making processes in all areas of the college activities.
- To suggest measures for bridging the gender gap.
- To Foster gender equality in all aspects of college community.
- To see a zero-tolerance policy to proactively for prevention of sexual harassment at the college

#### 3.3 Gender Wise facilities exist in the College

##### i) **Girls Hostel :**

Responding to the requests from female students, especially those from remote areas, the college has established a dedicated girls' hostel, segregated from the main campus, to serve both undergraduate and postgraduate female students. The hostel boasts a capacity to accommodate 450 students and features a separate mess and dining hall exclusively for them. Rigorous cleanliness practices are maintained to ensure a hygienic living environment. The residents are provided with nutritious meals, including breakfast, lunch, dinner, and milk twice daily. To ensure hydration, mineral water facilities and water coolers are readily available within the hostel premises. The hostels operate under the management of the students themselves.

To guarantee the safety of the residents, round-the-clock security guards are stationed at the hostel, supplemented by a permanent warden and three resident wardens to oversee the well-being of the students. Additionally, medical support is available on-call, with doctors accessible whenever required, ensuring a safe and comfortable living space for the girls.



**ii) Boys hostel:**

The college provides a boys' hostel designed to accommodate students enrolled in both undergraduate and postgraduate courses, offering a convenient and supportive living environment close to their academic settings. This facility is aimed at ensuring that male students have access to comfortable and secure accommodation throughout their academic journey. The hostel is equipped with essential amenities to support the students' educational and personal needs, creating a conducive atmosphere for study and relaxation. By offering this residential option, the college aims to foster a sense of community among its students, encouraging collaboration and mutual support as they pursue their academic goals. The availability of such accommodation plays a crucial role in removing barriers to education for students coming from various locations, making the pursuit of higher education more accessible and manageable.

**3.4 Facilities for Girls in the College****i. Girls common room:**

- a. Made exclusively for girls to take rest. There are separate common rooms for lady staff and girl students. There is an adequate place and silence is maintained for girls to study. Value oriented though provoking quotations are displayed in the room.

**ii. Girls Washroom:**

- a. There are separate ladies wash rooms for lady staff and girl students with adequate water supply and regular cleaning. sanitary pad and vending machine has been facilitated.

**iii. Ladies power gym and training centers (tailoring) are also there to empower the girl students of the college.****iv. The college is under the vigilance of 24x7 security guards and it also has CCTV cameras at crucial points.****3.5 Anti -Ragging Committee and Discipline:**

To ensure the observance of discipline and a healthy work and study atmosphere for every individual in the college various committees like anti ragging committee, discipline committee have been formed.

#### **4. COMMONLY USED TOOLS AND STRATEGIES IN GENDER AUDITING**

##### ***V. Survey conducted at the college level:***

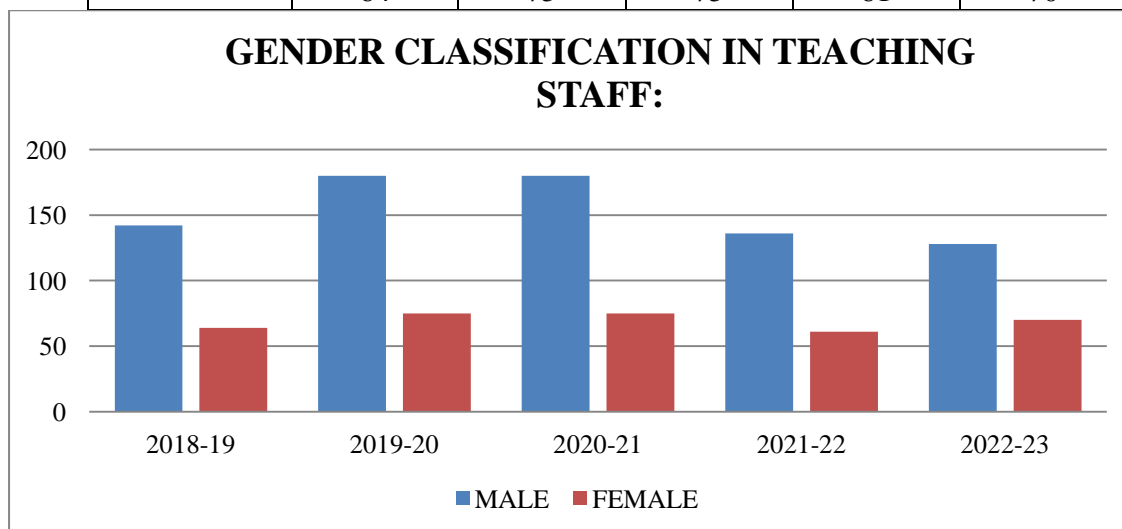

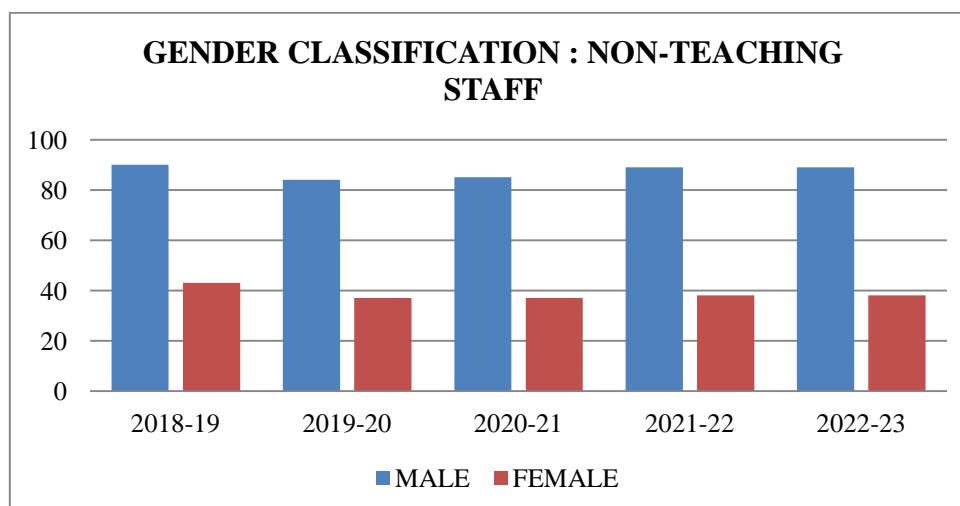

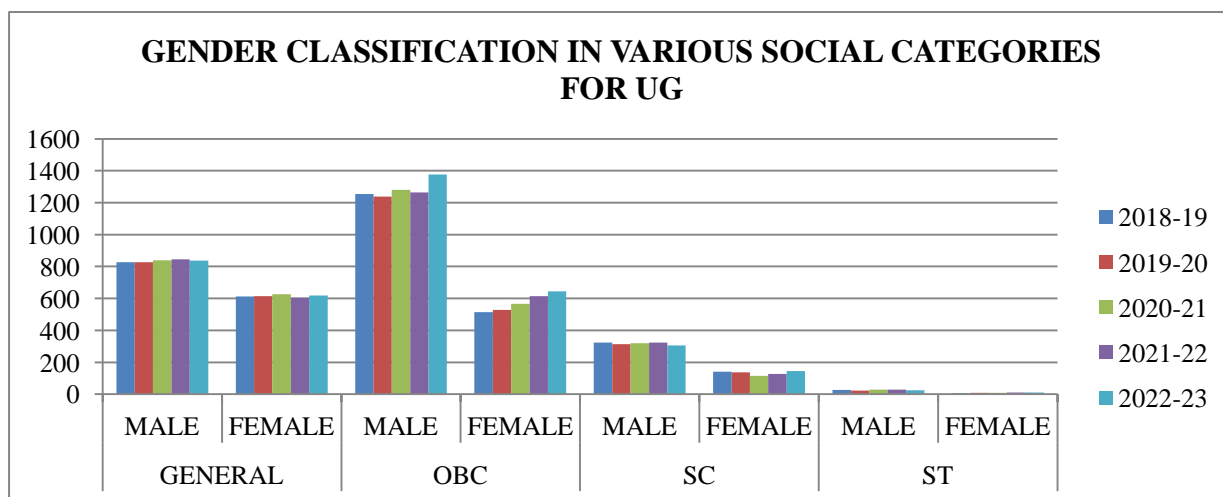

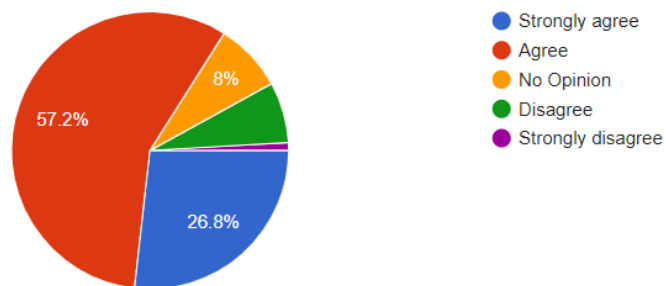

The Engineering College has implemented various initiatives to promote gender equality, as evidenced by student feedback. These initiatives include gender sensitization programs integrated into the curriculum, which 83.8% of students find effective, along with gender awareness programs such as sexual harassment awareness, supported by 86.3% of students. Moreover, the college ensures the availability of adequate toilet facilities for girls, as acknowledged by 86.1% of students, with additional amenities like disposal bins receiving approval from 84% of students. Security measures and lighting on campus are also commendable, with 89.2% and 91.1% of students respectively acknowledging their effectiveness both during the day and night.

Furthermore, flexible timing options for female students are available, according to 91.1% of students. The presence of a women's cell within the college, along with female faculty members, is recognized by 85.3% and 87.6% of students, respectively, indicating institutional support for gender-related concerns. While students generally feel free to reach out to the women's cell (74.6%), the establishment of a grievance redressal cell (77.8%) further ensures avenues for addressing gender-related issues. Overall, the college is commended for offering equal opportunities to all genders in classrooms, sports, clubs, and forums, with 94.3%, 88.5%, and 89.0% of students acknowledging this inclusivity, respectively.

However, to further enhance gender equality, it is recommended to continuously strengthen gender sensitization efforts, maintain and improve facilities, and encourage open dialogue to address any emerging concerns effectively.

**Recommendations:**

1. Strengthen and expand gender sensitization and awareness programs to ensure all students understand and respect gender equality.
2. Ensure maintenance and availability of adequate toilet facilities for female students.
3. Enhance campus lighting and security measures to improve safety, particularly at night.
4. Offer more flexible timing options to accommodate the needs of female students.
5. Promote the women's cell and increase awareness among students about its services.
6. Ensure the grievance redressal cell is accessible and responsive to concerns related to gender equality.
7. Foster an inclusive environment in classrooms, sports, clubs, and forums to provide equal opportunities for all genders.
8. Encourage and support free and fair expression of ideas among all students, regardless of gender.
9. Regularly assess and address any emerging gender-related issues on campus to maintain a supportive and inclusive environment for all students.
